

2. HAZARDS IDENTIFICATION

This product is a black, opaque liquid with a solvent odor. Liquid and vapors are flammable. May cause eye and skin irritation. Inhalation of vapors or mist may cause respiratory irritation and central nervous system effects such as headache, dizziness, drowsiness, nausea and unconsciousness. Prolonged and/or repeated overexposure may cause liver, kidney, and nervous system damage.

4. FIRST AID MEASURES

EYE: First check victim for contact lenses and remove if present. Flush victim's eyes with large quantities of water for at least 15 minutes, holding the eyelids apart. Get medical attention if irritation persists.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

HANDLING: Avoid contact with the eyes, skin and clothing. Avoid breathing vapors. Wear protective clothing and equipment as described in Section 8. Use only with adequate ventilation. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep product away from heat, sparks, flames and all other sources of ignition. 10. STABILITY AND REACTIVITY

STABILITY: Stable under normal storage and handling conditions.

INCOMPATIBILITY: Strong acids and oxidizers.
